Finalise payment

BPW Australia will advise you and the relevant Club of the status of your application and send you a tax invoice for the \$1,200 (including GST) annual membership.

Nominate your members

Your corporate membership allows you to nominate four women as members. These nominations are transferrable to other employees and may even be used in different Clubs if you wish to nominate four women in different locations. Once your membership fee has been received, your local Club will contact you to confirm the names and details of your organisation's nominated members. This is also a good time to nominate additional women employees at a discounted membership rate if you wish to enlarge the group of women in your organisation who benefit from your corporate membership.

Your local Club will keep you informed of its meetings, projects and activities, make sure your nominated members receive newsletters and meeting invitations, let you know about special events, and generally help you get the most out of your corporate membership.
